

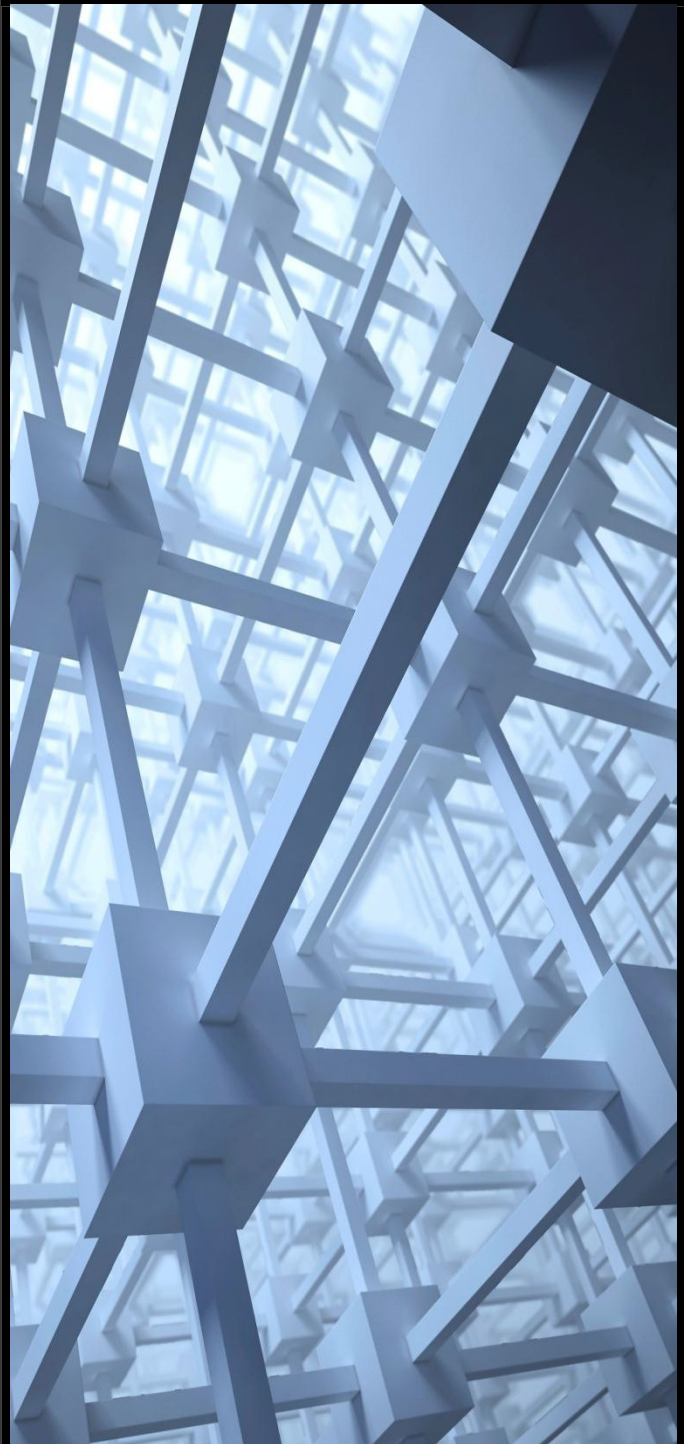

Overview

The Experience Modification Daily Subscription data file (Daily) and the Experience Modification Weekly Subscription data file (Weekly) include experience rating information as defined in California Insurance Code Section 11752.7(c)(1). Transactions include the employer name, address, experience modification, bureau assigned classifications and limited policy information.

Upon initial setup of either the Daily or Weekly files, the WCIRB will provide a master file of all experience rating information, including a DNQ (“does not qualify”) notation for risks that do not meet the experience rating eligibility threshold. Incremental updates containing newly issued experience modifications (or DNQ notations) will be issued daily or weekly, depending on the subscription. A subscriber may purchase a replacement master file separately at any time.

Eligibility and Ordering Information

The product is available to licensed California insurers and to registered California Advisory Organizations in good standing with the California Department of Insurance. A company interested in becoming a California Advisory Organization should review California Insurance Code section 11753 and contact the California Department of Insurance.

To begin the ordering process, complete Form 205 – *Experience Modification Subscription* available on the WCIRB’s public website and email the completed form to contracts@wcirb.com.

General Specifications

1. There are several records for each employer, each containing the Bureau Number assigned to that employer by the Workers’ Compensation Insurance Rating Bureau of California (WCIRB).
2. There are six record types:
 - Type 1 – Address (0 – 1 record per employer)
 - Type 2 – Experience Modification or DNQ Notation (1 record per employer)
 - Type 3 – Employer Names (0+ records per employer)
 - Type 4 – Classification Codes (0+ records per employer)
 - Type 5 – Coverage Information – only insurers of record receive this record type (0 – 1 record per employer)
 - Type 6 – File Count (1 record per file)
3. Records are fixed length at 176 bytes.

Additional Information on File Contents

The trigger for a risk/Bureau Number to be included in the Daily or Weekly file is the issuance of an experience modification during the incremental period, or the determination that a risk does not qualify for experience rating for a specific rating date.

The employer name, address, experience modification, bureau assigned classifications and limited policy information provided within the files is the information available at the time the files are created. Subsequent changes to non-experience rating information, such as updated name or address information, does not trigger inclusion in the Daily or Weekly files.

Additionally, when an employer is a client of a Professional Employer Organization (PEO), with few exceptions, only the client name and location address, as reported by an insurer, are included.

Delivery

The WCIRB uses FTP protocols to securely deliver this product to subscribers. Each subscriber will have a secure folder on the FTP server. Once a Daily or Weekly file is created, it is copied to the subscriber’s X-Mod Data File subfolder where it is compressed and encrypted with the subscriber’s public key. Files are moved to an archive subfolder once a week. The archive subfolder will be purged every 30 days. Subscribers will have read-only access to their folder and archive subfolder.

The data can be delivered using the following network protocols:

Protocol	Details
sFTP	Provides file access, file transfer, and file management functionalities over any reliable data stream as an extension of the Secure Shell protocol (SSH) version 2
FTPS	An extension to the FTP that adds support for the Transport Layer Security (TLS) and the Secure Sockets Layer (SSL) cryptographic protocols
HTTPS	Layering the HTTP on top of the SSL/TLS protocol, it adds the security capabilities of <u>SSL/TLS to standard HTTP communications</u>

Encryption Options

Files will be stored in the subscriber's home directory using the subscriber's PGP encryption. There is no option to receive data in an unencrypted format.

Service Level Agreement

The WCIRB typically produces experience ratings during a batch process that runs after normal work hours, 6 PM – 7 AM, Monday through Friday. The Friday night batch is occasionally delayed to perform system maintenance and deploy other system upgrades.

The Daily file is expected to be available in the WCIRB's FTP server by 9 AM, Tuesday-Friday, generally 95% of the time. The Daily file produced in the Friday night batch could be available in the WCIRB's FTP server as early as the next morning (Saturday) or as late as 9 AM the following Monday morning, generally 95% of the time.

The Weekly file is expected to be available in the WCIRB's FTP server by 9 AM every Friday, generally 95% of the time.

When either the Daily or the Weekly file is not available within the timeframes noted above, the WCIRB will send out a communication to notify customers of the delay. The communication will provide an estimation as to when the issue is expected to be resolved and when the file will be available. Periodic updates will be made as necessary.

Address Record (0 – 1 record per employer)

The address record typically reflects the employer's latest mailing address.
